BRIEF DESCRIPTION OF PERMIT REQUEST

A permit constitutes permission to maintain, store, use, or handle materials, or to conduct process that could produce conditions hazardous to life or property. Such permission shall not be construed as authority to violate, cancel, or set aside any provision of the International Fire Code or the District's Resolution adopting a Fire Code. Details regarding the above request must be filed when the application is made and whenever requested by the Fire Marshal. Before a permit is issued, a fire department official may inspect the premises to verify information regarding the permit application. In instance where laws or regulations are enforceable by any other governmental entity having jurisdiction over the area, joint approval shall be obtained. Permits shall be kept on the premises designated therein at all times and shall be posted in a conspicuous location on the premises, or shall be kept on the premises in a location designated by the Fire Marshal. Permits shall be subject to inspection at all times by an officer of the fire or police department or other persons authorized by the Fire Marshal. Permits may be revoked at anytime when it is determined by the Fire Marshal that any conditions or limitations set forth in the permit have been violated, which may result in fines or additional fees issued by the fire department.
