Notice is hereby given that a Regular Meeting of the Board of Commissioners of Williamson County Emergency Services District No. 4 will be held on **Monday, February 27, 2023, at 6:30 p.m.**, at the Liberty Hill Fire Station, 301 Loop 332, Liberty Hill, Texas, for the following purposes:

1. Call Meeting to order and establish quorum.
2. U.S. Pledge of Allegiance followed by the Texas Pledge of Allegiance.
3. Citizen Comment (Any individual may make a presentation relevant to the proposed business of the District of not more than two (2) minutes to the Board of Emergency Services Commissioners).
4. Review and approve the meeting minutes for January 23, 2023.
5. Hear Treasurer's Report and take appropriate action for the updated report for the 2022/2023 Budget Year.
6. Presentation and acknowledgement of former Commissioner James Baker for his service on the Emergency Services Board of Commissioners and to the community.
7. Discussion and possible action on Ronald Reagan widening and right of way acquisition from Williamson County ESD No. 4.
8. Discussion and possible action on approving an Interlocal Agreement with Williamson County to house an ambulance in fire station #2.
9. Discussion and possible action on completion of Station 2 buildout to handle EMS and additional fire staff.
10. Discussion and possible action authorizing staff to solicit Requests for Proposals (RFP) for Project Financing for several Williamson County ESD No.4 projects.
11. Discussion and possible action on purchasing of property, status of design, architectural and engineering work, architectural and engineering consultants and construction on Fire Stations #3 and #4, any future fire station sites and associated funding.
12. Receive monthly report from the Fire Chief regarding emergency operations, response times, call volume, training, management activities, and personnel and consider taking related action.

13. Announcements. Set the next meeting date.

14. Adjourn.

The Board may retire to Executive Session any time between the meeting's opening and adjournment for any purpose authorized by the Texas Open Meetings Act, including, but not limited to: consultation with legal counsel (Section 551.071 of the Texas Government Code); personnel matters (Section 551.074); discussion of real estate acquisition (Section 551.072); discussion regarding a prospective gift to the District (Section 551.073); and/or deliberation regarding security devices or security audits (Section 551.076). Action, if any, will be taken in open session.
