Notice is hereby given that a Regular Meeting of the Board of Commissioners of Williamson County Emergency Services District No. 4 will be held on **Monday, September 26, 2022 at 6:30 p.m.**, at the Liberty Hill Fire Station, 301 Loop 332, Liberty Hill, Texas, for the following purposes:

1. Call Meeting to order and establish quorum.
2. U.S. Pledge of Allegiance followed by the Texas Pledge of Allegiance.
3. Citizen Comment (Any individual may make a presentation relevant to the proposed business of the District of not more than two (2) minutes to the Board of Emergency Services Commissioners).
4. Review and approve the meeting minutes for August 29, 2022.
5. Hear Treasurer's Report and take appropriate action for the updated report for the 2021/2022 Budget Year.
6. Discussion and possible action authorizing a Banking Depository Agreement with R Bank to be the banking services provider for certain funds for the district including a resolution.
7. Discussion and possible action authorizing the purchase of Pumper Fire Apparatus from Pierce Manufacturing.
8. Discussion and possible action authorizing the Financing of a Pumper Fire Apparatus with PNC Equipment Finance including a resolution.
9. Discussion and possible action for Apparatus Purchase of an Attenuator truck to improve roadway safety and make improvements in risk management.
10. Discussion and possible action approving Order Disannexing +/- 300 acres of the district to the City of Leander.

11. Discussion and possible action on purchasing of property, status of design, architectural and engineering work, architectural and engineering consultants and construction on Fire Station #3 and #4 and associated funding.

12. Receive monthly report from the Fire Chief regarding emergency operations, response times, call volume, training, management activities, and personnel and consider taking related action.


13. Announcements. Set the next meeting date.

Action, if any, will be taken in open session.
