9. Authorize President Dan Clark to sign a Land use Contract between WCESD No.4 and Santa Rita KC, LLC for the use of property/land as a Temporary Station 2 site once documents have received Legal review.
10. Discussion and possible action on status of design, architectural and engineering work, architectural and engineering consultants and construction on Fire Station #2.
11. Discussion and possible action on completing our Fire Marshal hiring process.
12. Discuss and review Deed Recordation Affidavit for Edward's Aquifer plan submission and authorize Board President, Dan Clark to record and execute Affidavit and submit to TCEQ.

13. Receive monthly report from the Fire Chief regarding emergency operations, response times, call volume, training, management activities and personnel and consider taking related action.
